Mayor Bruce Armstrong led everyone present in the Pledge of Allegiance.

Under Special Order of Business Mayor Armstrong presented Miguel Galvez for a promotion within the Police Department.

Under Presentation and Approval of Minutes, Mayor Bruce Armstrong presented for approval the Minutes of October 13, 2020.

There was discussion regarding some typos to be fixed in the minutes. A motion was made to approve with these typos being corrected.

Under Introduction of Ordinances and Resolutions, Mayor Armstrong presented a CHARTER ORDINANCE EXEMPTING THE CITY OF HAYSVILLE, KANSAS FROM CERTAIN PROVISIONS OF K.S.A 14-111 AND PROVIDING SUBSTITUTE AND ADDITIONAL PROVISIONS ON THE SAME SUBJECT RELATING TO SPECIAL MEETINGS. Mayor Armstrong explained that this charter ordinance provides more flexibility to the Mayor and Council in regard to speeding up the process to have a special meeting called.

Motion by Crum- Second by Parton

Under Notices and Communications, Mayor Bruce Armstrong called for Governing Body Announcements. Councilperson Steve Crum reviewed hours at the Haysville Community Library. He stated early voting will begin on October 27th, 2020 and end Saturday October 31, 2020 at the Community Library. He also gave a reminder that there is a drop box for mail in ballots in front of the Police Station. Mayor Armstrong reviewed Senior Center activities and announced the Haysville Hustle Transportation Service will begin on Monday

November 2, 2020. Mayor Armstrong also presented a Memo Re: New Business, Twister Scissor Salon located at 7542 S. Broadway. Lastly, Mayor Armstrong thanked the Activity Center Staff, Police Department Staff, Public Works Staff, and volunteers for their efforts with the trick or treat event for the community children.

Under Other Business, Recreation Director Rob Arneson presented Consideration of Repainting Municipal Pool. He advised that the pool is in need of repainting and has not been painted since 2016. Arneson asked for approval to contract with Wild Cat Paintings for \$22,500 which includes repair of all cracks and repainting with a 1-year warranty on the work. He also advised Council this amount would be paid from the Capital Improvements Fund. There was some discussion amongst Council Members ensuring start and completion dates as well as ensuring this included the evaluation and repair of the four small pools.

Under Department Reports, on behalf of the City Clerk Department, City Clerk Angela Millspaugh advised that mail in ballots need to be postmarked by November 3rd, 2020. Chief of Police Whitfield advised that the Police Department participated in the "Drug Take Back Event" this past weekend where people were able to properly dispose of 207.35 pounds of medications. He also reminded everybody to be alert for trick or treaters on Halloween. Public Works Director Tony Martinez gave an update on the playground and shade structures at Dorner Park, the remodel at Public Works, and the remodel of Council Chambers at City Hall. Director of Recreation Rob Arneson advised council of the Gobble Wobble 5k run walk on November 7, 2020 at 9am. He also advised voting will take place at the Activity Center on voting day from 7am to 7pm.

There were no Off-Agenda Citizens to be Heard.

Under Bills to be Paid, Mayor Bruce Armstrong presented the Bills to be paid for the second half of October.

Under Council Items, Mayor Armstrong advised Council Action Requests for 401 N. Marlen has been completed and 187 N. Marlen is still being remodeled.
